ERNEST-ANTOINE SEILLIÈRE INVITED TO ADDRESS THE EUROPEAN COUNCIL

Invited along with ETUC President Candido Méndez and ECB President Jean-Claude Trichet by Chancellor Schüssel to speak at the opening session of the European Spring Summit on 23 March, UNICE President Ernest-Antoine Seillière presented the message supported by the Presidents of all 39 UNICE member federations that business expects a real commitment to implement the reforms for growth and jobs and update national reform programmes with more concrete targets and deadlines. The current wave of takeovers shows that the Internal Market is alive. But in view of recent interventions to limit market access and difficulties in pushing forward legislation to complete the Internal Market, President Seillière urged the European Council to resist national protectionism in order to avoid a negative domino effect, and recalled that Europe needs a meaningful services directive. He also called for a European energy policy which establishes competition on open and interconnected markets and for closer cooperation between Member States to ensure security of energy supply. He concluded that Member States must not miss the opportunity to take concrete steps to unlock business potential, especially for SMEs. On 17 March, to exchange views on how to strengthen EU-China trade and investment relations, UNICE President Ernest-Antoine Seillière met Ambassador Guan Chengyuan in Brussels. They discussed economic issues such as the WTO negotiations and the future of bilateral relations. China is a key priority for UNICE and its increasing interdependence with the EU offers major opportunities for European companies. WTO NAMA NEGOTIATIONS: GLOBAL MANUFACTURERS' COALITION URGES FOR MORE AMBITION

UNICE participated in a joint delegation to the WTO on 14-16 March with business partners from the US, Japan, Brazil, New Zealand, Korea and Taiwan to push for more ambition in industrial market access negotiations. The business organisations were concerned about the low level of ambition in the DDA industrial market access negotiations after several meetings with ambassadors in Geneva. Against that background, the coalition urged all WTO members to ensure significant gains in market access for industrial goods in OECD and emerging countries or they risked losing the support of business for ratification of the DDA. UNICE DISCUSSES INTERPLAY BETWEEN LABOUR MARKET REFORMS AND MACROECONOMIC POLICIES

At a conference organised by ETUC on 21 March, UNICE General Adviser Jean-Paul Mingasson reaffirmed that Europe's labour market difficulties cannot reasonably be blamed on macroeconomic policies. Yet, fiscal and monetary policy can, under certain conditions, ease implementation of the reforms needed to tackle these difficulties and help overcome a certain status quo bias linked to political economy constraints.
