UNICE RECALLS INDUSTRY'S CONSIDERABLE COMMITMENTS TO IMPROVE AIR QUALITY

At a public hearing on 20 April organised by Mr Krahmer, the European Parliament Rapporteur on the air quality directive, UNICE underlined that companies are investing considerable efforts to improve air quality. While the Commission supports uniform air quality targets, industry as well as municipalities and regions insist on the need for some flexibility that would acknowledge efforts deployed so far. It would be unfair to penalise cities or companies that already have emissions reduction plans in place. This aspect is well reflected in Mr Krahmer's report. Industry also advised to continue scientific in order research better to understand the relationship between sources and exposure before deriving highly ambitious policies, and hence ensuring cost-efficient and targeted measures. UNICE CAUTIOUS ABOUT ENCOURAGING LITIGATION FOR ANTITRUST INFRINGEMENTS

On 21 April, UNICE submitted its reaction to the Commission's Green Paper on damages actions for breach of EC antitrust rules. UNICE recognises that the public and private enforcement of antitrust rules is fundamental for creating and sustaining a competitive economy but doubts whether encouraging more litigation is the right way forward. Competition law is a relatively complex area of law which involves a lot of economics, and more court actions would increase chances of divergent decision-making with obvious negative implications for the integrity of the internal market and the ability of companies to compete on merit. Apart from this, there are other disadvantages of increased litigation. Significant transaction costs serve no public interest objective and the uncertainty and burdens brought about by more court actions could also lead to companies avoiding new forms of innovative and pro-competitive behaviour to the detriment of their competitiveness.
