## **UNICE SUPPORTS PRIORITIES OF THE FINNISH EU PRESIDENCY**

In the first week of the new Finnish Presidency of the European Union, UNICE President Seillière paid a visit to Helsinki on 6 July, to present European business expectations for the next six months. Accompanied by Christoffer Taxell, President of the Confederation of Finnish Industries – EK, Leif Fagernäs, EK Secretary General, and UNICE Secretary General Philippe de Buck, he had a meeting with Minister for Trade and Industry and President of the Competitiveness Council, Mr Mauri Pekkarinen, with a fruitful discussion on UNICE expectations from this Council formation on important dossiers such as innovation and research, REACH and better regulation. Furthermore, meeting Finnish Prime Minister Matti Vanhanen, UNICE President Seillière gave his support for the priorities of the Finnish Presidency, uppermost of which are "the future of Europe" and "competitiveness". With the failure of the WTO Ministerial in Geneva last week and the crucial end-of-July deadlines rapidly approaching, UNICE, the Confederation of European business, and the Japanese business organisation Nippon Keidanren are concerned about the slow progress achieved since the WTO Hong Kong Ministerial. In a joint statement, they urge WTO members to exercise the political leadership needed to achieve successful and ambitious results in the negotiations before the end of 2006. # **REACH SOON TO BE BACK IN THE EUROPEAN PARLIAMENT**

The European parliament will begin its second reading on REACH in September, with the aim of having the second reading completed in plenary during the Finnish Presidency. #### THE EUROPEAN SERVICES PLATFORM FOR MORE COMPREHENSIVE INFORMATION AND ANALYSIS

Internal market issues on services are increasingly important in the EU and also have a strong impact on external-related aspects. Hence, more comprehensive information is becoming indispensable for all trade organisations dealing with services. UNICE and ESF decided to join forces in November 2005 and have created the European Services Platform (ESP). The ESP is an informal platform for exchanging information on horizontal services issues and facilitating analysis of ongoing services-related debates such as the directive on services in the internal market. #### THE TRUTH ABOUT RELOCATION

At a conference on "Relocation – challenges and opportunities" organised by the European Economic and Social Committee on 29 June, taking part in a panel discussion with, among other speakers, Mr John Monks, ETUC Secretary General, UNICE Secretary General Philippe de Buck underlined that the highly mediatised phenomenon of companies moving their production to places where labour is less expensive also offers many benefits, which are often overlooked: for example, products and services become cheaper for consumers everywhere, and developing countries become richer and thus more important trading partners. Contrary to common belief, a relocating country is often better off after relocation, if its economic structure is sufficiently flexible to allow displaced workers to find work quickly in more productive sectors. On 3 July 2006 UNICE participated in the regular meeting of the OHIM users' group in Alicante with other organisations representing users of trademark and design rights to discuss trademark- and design-related issues. UNICE was represented by Gerhard Bauer from DaimlerChrysler and Ilias Konteas, UNICE Legal Affairs Adviser. OHIM informed participants about the results of the users' satisfaction survey conducted in 2005 and its impact on the Office's future policy as well as about the status of its various e-projects to facilitate proceedings for applicants with increased use of information technologies.
