UNICE President and Secretary General visit Copenhagen

Under the provocative title of "Mission Possible" the Confederation of Danish Industries (DI) on 26 September hosted in Copenhagen its annual conference with UNICE President Ernest-Antoine Seillière as guest speaker. Mr Seillière gave an address on the overall opportunities and threats that Europe is facing in global competition with special attention to the labour force challenge. The President and Mr de Buck also discussed bilaterally with President Vorsholt and Director General Neergaard Larsen of the Confederation of Danish Employers (DA) on the main European and Danish priorities for the coming months. UNICE MEETS PRESIDENT OF COMPETITIVENESS COUNCIL

Ahead of the first official Competitiveness Council under the Finnish EU Presidency on 25 September, a UNICE/EK delegation headed by Philippe de Buck met Mauri Pekkarinen, Finnish Minister of Trade and Industry and current President of the Competitiveness Council. They exchanged views on the issues UNICE had put forward one week before in a letter to Mr Pekkarinen on the occasion of the Competitiveness Council meeting, notably innovation, the Internal Market strategy and consumer policy. EXCHANGE OF LETTERS BETWEEN UNICE AND THE CHAIR OF THE EP INTERNAL MARKET COMMITTEE

Following the letter by Arlene McCarthy published in the Financial Times on 21 September in which the chairwoman of the EP Internal Market Committee referred to UNICE's stance on the services directive, there was an exchange of letters between UNICE Secretary General Philippe de Buck and Mrs McCarthy. UNICE sent a response letter that was published in the same newspaper on 25 September. It aimed at clarifying UNICE's view on the services directive as it now stands after the political compromise and pinpoints the difficulties it will encounter in the transposition and implementation phase. The letter also stresses the importance of the internal market for companies and the need for improvement. Philippe de Buck also wrote to Mrs McCarthy and forwarded to her several documents illustrating European business views and difficulties in the internal market and presenting proposals for the way forward. UNICE AT THE 6TH EURO-MEDITERRANEAN MINISTERIAL CONFERENCE ON INDUSTRY

On 21-22 September in Rhodes, UNICE and the Union of Mediterranean Confederation of Enterprises (UMCE) were represented at the highest level at the 6th Euro-Mediterranean Ministerial Conference on Industry by Mr <u>Ulysses Kyriacopoulos</u>, UNICE Special Representative for Mediterranean Affairs, and Mr Omer Sabanci, UMCE President. Mr Kyriacopoulos voiced for Euro-Mediterranean Ministers the point of view of the private sector on how to meet the challenges of globalisation and the opportunities for the South Mediterranean countries under the European neighbourhood policy. He also clearly explained the importance of attracting foreign direct investment as a driver to address the challenge of globalisation. UNICE AGAINST FRAMEWORK LEGISLATION ON SERVICES OF GENERAL (ECONOMIC) INTEREST

In view of the plenary deliberation on the report by Mr Rapkay on the Commission's white paper on services of general interest, UNICE has written to all members of the European Parliament reminding them of UNICE's strong opposition to specific EU legislation in this field. Horizontal legislation would be totally counterproductive. Bearing in mind the great diversity of these services, it would be unworkable. It would also be unnecessary, given the major progress made in the field of SGI over the last ten years, not to mention highly damaging for economic and social development. Protectionist influences would be reactivated and obstacles to competition and private entrepreneurial dynamism reintroduced. The successful system of subsidiarity in place at present should not be burdened by new European rules at a time when there is a general commitment for simplification of EU legislation and a more targeted decision-making. UNICE PRESSES CASE FOR TRADE LIBERALISATION AT W TO PUBLIC FORUM



On 25 September, UNICE WTO Working Group Vice-Chair Reinhard Quick addressed attendees at the WTO's Public Forum 2006, stressing that a renewed focus on trade liberalisation needs to be at the core of the WTO's activities in the 21st century. He spoke on a forum panel entitled "Neo-Protectionism: 21st Century Challenge for the WTO" – organised by UNICE in cooperation with the APEC Business Advisory Council. Mr Quick characterised the suspension of the Doha

Round as the most obvious example of resurgent protectionist tendencies linked to blinkered notions of what countries need in order to develop. He also addressed the issues of non-tariff barriers such as export taxes, the need for greater differentiation between developing countries according to real economic criteria and the problems posed by negotiations on environmental goods. CLARIFICATIONS NEEDED ON RUNNING AND CONCLUSIONS OF REACH IMPLEMENTATION PROJECTS

At a conference organised by the Commission on the REACH implementation projects (RIPs) on 25 September, UNICE General Adviser Jean-Paul Mingasson raised three particular concerns: a broad consultation of industry is needed when the conclusions of these projects are being prepared; RIPs need to be finalised well before the REACH implementation deadline; RIPs need to remain short and simple to fulfil their objectives of facilitating REACH implementation. MERCOSUR: EU BUSINESS SUPPORTS RELAUNCH OF NEGOTIATIONS

On 25 September, UNICE hosted a meeting of the EU members of the Mercosur-EU Business Forum (MEBF). Participants underlined their concern with the lack of progress in the bi-regional EU-Mercosur free-trade negotiations and supported their rapid relaunch. To contribute to that aim, a MEBF Plenary Conference will be held in Buenos Aires on 6 November with the expected participation of EU and Mercosur business leaders and decision-makers. As part of the EU social dialogue work programme 2006-2008, European social partners agreed to undertake a joint analysis of the key challenges facing European labour markets. JAPANESE AND EUROPEAN BUSINESS SHARE CONCERNS ABOUT IASB

On 18 September UNICE met a delegation from Nippon Keidanren, the Japanese business confederation, headed by Yoshiki Yagi, Chairman of Hitachi. While sharing the common objective of eventual worldwide harmonisation of international accounting standards, both organisations have common concerns about the future of the International Financial Reporting Standards (IFRS), the accounting standards which EU companies are using and towards which Japan is converging. In particular the governance of the International Accounting Standards Board (IASB), responsible for IFRS, is a cause for worry as well as some of its current projects, such as presentation of financial statements, business combinations or the conceptual framework discussion.
