Key Government initiatives

- 2008 Climate Change Act + binding CO2 targets
- Committee on Climate Change: 3 x 5-year carbon budgets/ 3 priority sectors
- Powers to create new CO2 markets: CRC
- Local Carbon Industrial Strategy, LCIS
- "Active" industrial strategy/green stimulus
- Stakeholder engagement
- UNFCCC towards a FAB deal

COALITION GOVERNMENT PRIORITIES

- Evidence of continuity of consensus ...
- "We will implement a full programme of measures to fulfil our joint ambitions for a low carbon, eco-friendly economy"
- o June Budget 2010
- Early initiatives: Energy Bill; increased renewables ambition; enhanced 2020 target; homes insulation; Green Investment Bank; aviation...

FORUM FOR A JUST TRANSITION

Terms of reference

- Provide oversight on the delivery of the Government's 2009 UK Low Carbon Industrial Strategy and its social impact across the UK
- Discuss, and where appropriate take action on, an overarching vision for a low carbon economy [to] aid the execution of the LCIS, and identify where to build on the commitments so that the strategic approach properly reflects short, medium and long term needs.
- Consider and offer views to Ministers on what further developments of Government policy are needed to ensure a fair distribution of costs and benefits for the whole of the UK economy
- Advise on what further economic analysis is needed for the successful development of the UK Low Carbon Industrial Strategy and Low Carbon Transition Plan.

Greenworkplaces

- 27% CO2
- o Energy, resources, waste, travel
- 2005: 6 pilot projects + training course development: CT match-funded
- Joint union-employer initiatives launch events, surveys, joint committees
- o 2010: 1,300 sites − Corus, British Museum, power sector, hospitals, TUC ...
- Next steps: national network; time off and training

LOW CARBON SKILLS

- Consultation, reports not action
- "Low carbon cluster" of Sector Skills Councils Key issues
- STEM skills to drive growth
- TUC "Greenworkplace" initiatives =
 Leadership & project management
- Climate change awareness and adaptation

Ways forward for climate policy

- o "just transition" and "decent work"
- Stakeholder engagement: UNFCCC EU/national/workplace levels
- Dual focus on social and economic opportunities and challenges of transition
- Cuts? Then use procurement for new technologies
- STEM and leadership skills
- EU priorities:
 - Intelligent Energy Europe
 - Stakeholder forum
