

# Establishing criteria for Employers' organizations and arrangement of the Employers' Register. Results.

- October 3, 2013

**Amendments to the Law on Associations and Foundations** stating that **associations** founded according the Law on Employers' organizations and asociations **are registered** in Associations and Foundations Register **as Employers' organization**

# Development of modern regulation of trade unions. Results.

- ✿ Draft law «**Trade Union Law**»
- ✿ Second reading in the Parliament



## (2) Social partner activities for implementation of the Framework Agreements. Planned.

- Information campaigns
- Erga omnes* collective agreement between LDDK and LBAS in a form of a pilot project
- Adoption of guidelines
- Preparation of regular joint reports on framework agreements to the European social partners



## (3) Social partners' contribution to the national agenda

### Bipartite social dialogue

- **General Agreement** between Employers' Confederation of Latvia (LDDK) and Free Trade Union Confederation of Latvia (LBAS)
  - ✓ 2004: Commitment to cooperate in number of areas – setting a minimum wage, health and safety at work, vocational education etc.
  - ✓ 2007: Aimed at sustainable development of Latvian economy, favourable social economic conditions, welfare of people, improving work relations and work environment, strengthening organized civil society.
  - ✓ 2010: Aimed at sustainable development of Latvian economy, social welfare, balance between flexibility and security, reduction of undeclared labour.
  - ✓ 2013: Aimed at sustainable development of Latvian economy, rising labor productivity, continuing structural reforms, creation of products and services of high added value to ensure competitive working places and adequate wages.

### (3) Social partners' contribution to the national agenda

*Inter alia* common goals:

- Improvement of health and safety conditions of workers
- Facilitation of equal opportunities for men and women, families with children, persons with disabilities, youth, pre-pension age persons and pensioners in the labour market
- Facilitation of favourable social conditions
- Quality education and improvement of qualification of workers
- Common implementation of Framework of Actions on Youth Employment
